- I acknowledge that the overnight camping rate is based on 1 camping unit, 1 family of 2 adults and 2 children or less and 2 cars/vehicles per campsite. Extra camping units or cars not allowed. Additional occupants of the campsite will result in a charge, per person. The total may not exceed 6 total occupants, 4 of which may be adults. 0
- **Check-in:** 4pm **Check-out:** 3pm
- **Quiet Hours and Curfew:** All campers and their guests must comply with the following:
 - **Quiet Hours** Friday and Saturday after 11pm and Sunday-Thursday after 10:30pm. Disorderly conduct or noise during this time will not be tolerated. If a 2nd warning is needed, violators must leave the premises the following morning, without refund.
 - **Curfew** Sunday-Thursday at 10:30pm; Friday and Saturday at 11:00pm or 15 minutes following a Fish Lake event. Curfew applies to all individuals under 21. Fish Lake Beach reserves the right to enforce other curfews.

1. **Guests** must pay daily admission. Campers are responsible for the conduct of their guests. Guests must leave by 10:00pm. Guests not admitted after 9pm without permission by management. Overnight guests must register in the office or at the gate. The number of occupants may not exceed 6 total, 4 of which may be adults
2. **Occupancy** Members of the family may not occupy the site or camp unit at any time without parent supervision.
3. **Dogs** are allowed at Fish Lake Beach. They must be contained or controlled on a leash. Owners must pick up their dogs waste. Dogs not allowed on beach or in swimming areas. No guard dogs or aggressive dogs. More than 2 dogs requires management permission. Loud or incessant barking will not be tolerated. Use of the Fish Lake Beach Dog Park requires strict adherence to the rules posted at the park. All dogs must be current with rabies/distemper shots.
4. **Gates** The entry gate opens using the access card provided at registration. The access card is active during the reservation period. Anyone that causes damage to the gate equipment is subject to a \$700 fine. The gate area is video monitored 24x7.
5. **Trees** may not be cut, nailed, climbed, damaged or have cords, clotheslines, swings, hammocks or ropes attached.
6. **Garbage** must be bagged and put in green dumpsters. Dispose of paper, cardboard, glass and plastic in **recycle** dumpsters near pavilion.
7. **Campfires** are allowed in designated fire scars only. No new scars permitted. No hatchets or axes may be used without adult supervision. Do not leave fires unattended. Do not move fire ring from campsite.
8. **Driving and Parking** All campers and their guests must obey stop signs and posted speed limits (5 mph & 10 mph). Do not drive excessively or park picnic area on weekends or holidays. Rocks, blocks or obstructions may not be placed on roads.
9. **Swimming** Campers and their guests must obey rules posted at the lake and beach. Beach hours are 10am-6pm when a lifeguard is on duty. Swimming permitted in the roped off area of the lake. Pool hours are 9am-11am for Adults only, 11am-5pm Family swim and 6pm-8pm Family swim. Hot tub is open until 10pm. Its use is strictly for individuals 17 and older. Individuals under 16 years old must be supervised by an adult.
10. **Fishing** Individuals over 15 years old must have a Illinois fishing license. Shore fishing ends at curfew.
11. **Bicycle and non-motorized scooter riders** must obey STOP signs. No racing or reckless riding. No riding after dusk. Motorized childrens vehicles may be used with immediate adult supervision.
12. Waste water may not be allowed to run on the ground.
13. No trenching around tents.
14. Guns, bow & arrow, and fireworks are prohibited at Fish Lake Beach.
15. It is mutually acknowledged and agreed licensee (camper), licensee's families and their guests may be photographed, videotaped, and audiotaped while camping on Fish Lake Beach Inc.'s property, these may be used for promotional purposes of Fish Lake Beach Inc. Fish Lake Beach Inc. has consent of the licensee (camper), licensee's (camper's) party and its guests to perform such activities. The licensee (camper), licensee's party and their guests agrees and consent to the use of such photographs, video or audio to be used in the future by Fish Lake Beach Inc. in accordance with their desires. Licensee (camper), licensee's parties and their guests, waives any claims as to intrusion of privacy or the like. The Management is not responsible for accidents or losses. Any licensee (camper) that violates these provisions may have their permit terminated. No Refunds. By Signing below you are representing all parties camping on your site.
