Registration Process

- 1. **Registration forms** must be completed online and supporting documents emailed to <u>camping@fishlakebeach.com</u> by March 31th 2021. Filling out the forms must be completed on a desktop, tablet or laptop computer-<u>using a smartphone is not recommended.</u>
- 2. **Supporting documents** below must be sent to camping@fishlakebeach.com with the site number in the subject line. Each picture and/or scanned image must be readable, in full and **not folded or cut off.**
- Drivers license of each individual on these forms: License Application and Unmarried Children Under 25 That Reside At The Licensees Home
- Vehicle registration for each vehicle on these forms: License Application and Unmarried Children Under 25 That Reside At The Licensees Home
- Current Insurance Policy for the RV/unit
- Title**
- 3. **To obtain vehicle passes:** Completed registration forms, supporting documentation and all outstanding balances must be paid before vehicle passes are prepared. Once prepared, an email will be sent to the primary licensee with the subject: 'your passes are ready!". Passes will not be prepared if registration forms are incomplete, supporting documentation are missing or outstanding balances exist.

Payment in full is due by **April 15th 2021**. A \$25 discount is offered for payment in full by **February 1st 2021**. US Hwy 12 Volo Illinois 60073 or call 847-546-2228 to make a credit card payment by phone. A 3% surcharge applies to credit card payments. Payment in full of all outstanding balances is **required to obtain vehicle passes**. Licensees that pay in full by April 15th 2021 will receive **10 FREE Guest Passes**.

FAQ: Licensees, Title, Passes

As licensees fill out the registration forms we tend to get questions about who can be a licensee, who gets free vehicle passes, and title information required. Please refer to the answers below. These answers can also be found in the registration forms, the Permit and License Agreement and Seasonal License Handbook 2021.

Licensee(s): The <u>primary licensee must be named on the unit title</u>. If there is a <u>secondary licensee</u>, that <u>individual must reside at the same address as the primary licensee</u> and sign the registration forms where required. If there is <u>not a secondary licensee</u>, you may fill out the non-licensee, Vehicle Passholder fields to get a vehicle pass at no charge.

Title**: A copy of the original trailer/unit title must be on file with Fish Lake Beach. If the unit title is **not in the licensees name**, the licensee must **apply for a title change and provide the updated title to our office or email to camping@fishlakebeach.com**. If the title is held by a lender we will accept a copy of the **application for the trailer title**; **many lenders** provide a **copy of the title** to the customer.

Passes: The license includes <u>up to 2 vehicle passes</u> for vehicles <u>owned and driven</u> by the **primary licensee** as well as vehicle passes for the licensee(s) <u>Unmarried Children 25 or Under That Reside At The Licensee(s) Home</u> and <u>up to 2 vehicle passes</u> for vehicles <u>owned and driven by the secondary licensee.</u> Please do NOT enter names and information on the Unmarried Children 25 or under form if the individuals are NOT 1.Unmarried children of the licensee 2. 25 years old or under 3. Residing at the licensees home

To buy additional vehicle passes send an email to camping@fishlakebeach.com with the quantity of additional vehicle passes needed and the site number in the subject line. We will reply with an invoice. To obtain the vehicle pass(es) the invoice must be paid in full and a copy of each passholder's drivers license sent to camping@fishlakebeach.com with the site number in the subject line.

*Golf Cart Permit: Beginning in 2021 we require a state issued, persons with disabilities placard or disability license plate to obtain a Golf Cart Permit and a \$50.00 permit fee will apply for the season. Seasonal licensees approved for a Golf Cart Permit form prior to 2021 will NOT need a state issued plate or placard. Additional details are available in the Seasonal License Handbook 2021.
